# **Our Commitments**

To address the above areas, BDO has adopted the following commitments:

Measurement	Collect and analyze data on the significant environmental impacts outlined above
Management	Maintaining our Integrated Management System to the ISO14001:2015 & ISO50001:2018 standards through continual improvement
Targets	BDO LLP commits to reduce absolute scope 1 and 2 GHG emissions 50% by FY2030 from a FY2020 base year. BDO LLP also commits that 80% of its suppliers by emissions covering purchased goods and services, capital goods and business travel, will have science-based targets by FY2027. Furthermore, BDO LLP commits to reduce absolute scope 1 and 2 GHG emissions 90% by FY2050 from a FY2020 base year. BDO LLP also commits to reduce scope 3 GHG emissions 97% per full time employee within the same timeframe.
Communication	Engage with our people_to promote strong environmental awareness and behaviour. Communicate our Environmental & Energy policy and our wider approach internally and externally via the firm's communications channels and environmental champions
Energy use	Record and regularly evaluate current and future energy use to identify potential firm wide reductions
